### c. Huntercombe Golf Club

Councillor's had met with the golf club. The golf club had erected temporary fences to protect the course when golfers are walking across in wet weather. Mole traps were not allowed. The area at The Crown should not be used for parking as it was common land. The club had erected leylandi fencing in front of the native hedging by the two new houses to try to prevent balls landing in the garden. The fairway had been moved away from the gardens. A new manager from Badgemoor Golf Club would shortly be taking up the position.
