NUFFIELD ANNUAL PARISH COUNCIL MEETING HELD AT 8PM ON 19th January 2023

1. Apologies

2. Declarations of Personal or Prejudicial interests

3. Confirmation of the minutes of 10th November 2022

These minutes were agreed and signed by the chair.

4. Actions and matters arising from those minutes

a. Dog bin – Huntercombe area – sadly we have gone full circle and as the dog bins are not on relevant land, SODC would not replace them with normal bins and will not remove them. Due to the excessive cost, investigate getting one removed and reduce the cost, if costs do not reduce by 50% the proposal is to be discussed with HRA.

Mays farm bus stop bin – clerk chasing progress with SODC.

b. Motorbike Noise and speeding in the Village

Crowmarsh Parish Council held a meeting with the Police and Crime Commissioner, Matthew Barber, and members of the Thames Valley Roads Policing team on Thursday 8th December to discuss concerns about speeding traffic. Outcome of the meeting was disappointing with a lack of commitment to future action – Parish Council raised with SODC and will continue to keep the subject in the forefront to attempt to reach some resolution.

Speeding in the Village

Multiple FMS tickets raised including a request for a meeting to discuss traffic calming but as yet no progress. Having approached OCC Councillor Felix Bloomfield to discuss including the potential for having a speed survey through the village, it is clear that prioritisation will apply and, as the road is already 30mph it is likely to be costly with little progress. Discussions are also ongoing regarding the stretch at Port Hill and an estimate for changing the speed here was set at a min cost of £10k +VAT. The gates along timbers Lane will however be a good start and further highlight to drivers that they are entering a residential area.

c. Request from Huntercombe Golf Club to alter the 30mph sign coming into Nuffield - Site line for golfers crossing –quotation for lower gate style signage has been obtained and the Golf club have agreed in principle to cover the cost and

installation. Final quote sent to Huntercombe Golf Club 12.01.223 for approval and OCC have confirmed provision of new speed sign/post.

d. General maintenance -

Bus stop roof repair to be scheduled but two volunteers have offered assistance.

Bus stop signs along A4130 - now replaced

New signs on timbers lane by golf course – ordered and in progress

Potholes – growing number of reports around the Parish roads

Grass cutting – new quotes received and maintenance contact from Bix has offered a good price which would reduce costs even if a few extra mows were requested on an ad-hoc basis during the year. C £500 compared to over £1.4k from Elite.

5. Holy Trinity Nuffield

Friends of Nuffield have some funds to contribute to the upkeep/maintenance of the church e.g. a proposal that has been put forward for a footpath across the churchyard to the car park.

6. Report OCC

Cllr Felix Bloomfield has confirmed that the grass cutting and path clearing works along the route to Nettlebed is the responsibility of OCC which would provide savings to the Parish Council. OCC would carry out work once a year.
